1. Contact your company's Human Resources Office and request a matching gift form. *Retirees may be eligible.*
2. Complete the required employee/retiree information.
3. Indicate the name of your company on the Bishop's Annual Appeal pledge card.
4. Refer to the inside of this brochure to determine which charitable entity qualifies for a matching gift from your company.
5. Make your check payable to the eligible entity.
