Let me assure you that all Bishop’s Annual Appeal funds are used, without exception, to support the vital ministries and services offered by the Diocese of Metuchen. These contributions are never used to pay legal fees or settlements from sexual abuse cases. In fact money contributed to the Appeal helps to fund programs to prevent sexual misconduct in any form through the Office of Child & Youth Protection.

Please continue to pray that healing, truth and hope may be found throughout our universal Catholic Church. As we persevere throughout the current crisis, may we be active instruments of God’s mercy and faithful stewards of the Gospel through prayer, word and deed.

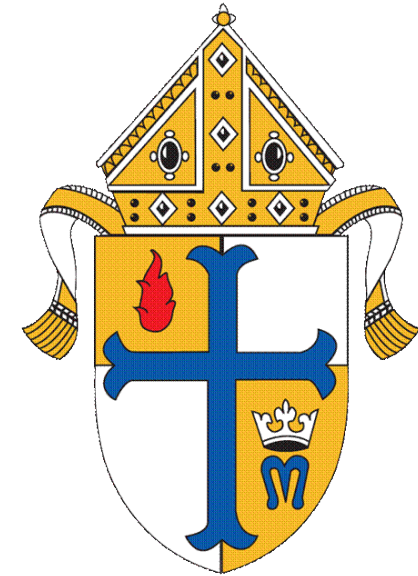

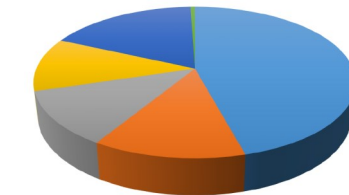
